**VERIFICATION CONSENT FOR ELIGIBLE NON-CITIZEN FAMILY MEMBERS**

**Warning:** Title 18 US Code Section 1001 states that a person is guilty of a felony for knowingly and willingly making a false or fraudulent statement to any department or agency of the United States.

The Chicago Housing Authority (CHA) must verify the eligibility status of all non-citizen family members so that the Housing Choice Voucher (HCV) Program can determine the family’s eligibility and/or level of subsidy payment.

**Note:** Please be advised that evidence supplied with this form may be released by the housing agency, without responsibility for its further use or transmission, to the USCIS for purposes of verification of the immigration status of the individual or HUD, as required. CHA or HUD is not responsible for the further use or transmission of the evidence or other information.

I authorize CHA to verify my immigration status with the USCIS. I am providing CHA with the supporting documents for my status.

In addition to giving CHA the right to verify immigration status, family members claiming eligible immigration status must provide CHA with one of the following documents (original documents only, no reproductions).

- Form I-551, Alien Registration Receipt Card
- Form I-94, Arrival-Departure Record (with appropriate annotations or documents)
- Form I-688, Temporary Resident Card
- Form I-688B, Employment Authorization Card
- A receipt issued by the USCIS stating that an application for issuance of a replacement document in one of categories above has been made and the applicant’s entitlement to the document has been verified.

**Note:** Original documents should not be mailed to the office. Please bring them to an HCVP Office in person. If you do not have the required document(s), contact the USCIS in the Department of Homeland Security to obtain originals. If the proper documentation is not presented and verified, your family’s rental assistance may be reduced, denied or terminated as provided by and HUD guidelines and HCV Program rules and regulations.
